

**Minutes of meeting of Nodal Officers UNDER CMCHIS held on Oct 1<sup>st</sup>, October 3<sup>rd</sup>, October 4<sup>th</sup>.**

The Following points were discussed

1. It was decided that the Medical officers will henceforth only sign with seal ,name designation ,registration number,institution name .It is also permitted that the same may be done in computer format .
2. The Discharge summary will be filled in complete with investigations in detail, Date of Admission, Date of Surgery, Date of Discharge and Discharge Advice and course in Hospital, Operation notes to be in brief with medications dosage and duration to be mentioned.
3. It was decided that henceforth that for the Travel Expenses in CMCHIS for meetings to TNHSP ,the expenses be met from CMCHIS funds after Committee resolution(JDHS)
4. It was decided that the meetings of Nodal officers be held through Video Conferencing Once in Two Months(Action: TNHSP)
5. It was permitted that manpower specialized can be hired subject to nonavailability in Government hospitals at the rate approved by the Committee for the purpose of Expenditure.
6. It was decided that Nodal Officers Be selected by seniority subject to the approval of the CMOs incharge of the hospital.
7. JDHS Dharmapuri to talk to PD regarding the diversion at Head Quarters Hospital, Pennagaram.
8. It was decided that The Director Of Medical services visit Krishnagiri G.H to sort out the Problems under CMCHIs there.(Action DMR&HS)
9. It was decided that manpower be hired for specialized medical work in hospitals like Tindivanam, Cheyyur subject to nonavailability in the respective institutions( Action: CMOS/JDHS)
10. Regarding Mettur GH the diet problem to be sorted out by Medical Officer with DMS(Action: DMS)
11. In Thuthukudi 2 (TWO)radiographers to be engaged(action Point: Hospital superintendent)
12. If some patient from non insured type require implants or other treatments requiring expenditure, Money accruing under CMCHIS may be spent for non insured patients subject to Committee approval (Action: JDHS/CMOS)
13. In Kovilpatti GH, The CMO not to retard the oncology cases treated at Kovilpatti(ACTION: CMO/JDHS)
14. Follow up procedures to be given at all Government empanelled Hospitals.
15. In Aranthangi GH the ortho equipments to be procured from CMCHIS funds (action CMO /JDHS)
16. Honararium may be paid to anesthetics outside duty hours , provided not in day time nad not in duty hours.
17. Incentives to be given only to those who are directly involved like audiographers(action: CMOS/JDHS).

18. For HEPA filter issues in certain hospitals where not installed it may be installed from CMCHIS funds subject to priority and committee decision .(action: CMO/JDHS)
19. In Dindigul, additional Ghs like Kodaikanal, Ottanchatiram, Vendasandur to be empanelled(Action: tNHSP)
20. 17 (A) charges to be framed against CMO Karai kudi due to the low performance under CMCHIS.
21. Explanation to be called for against Ambasamudhiram CMO due to the low performance Under CMCHIS.
22. 17(A) charges to be framed against the CMO thiruthurai pondi due to poor performance under CMCHIS
23. The Committee may be permitted to buy laptops and other devices which are essential for the scheme.
24. The package costs for TKR/THR for uncemented to be worked out.
