

**MINUTES OF THE TWENTY NINTH EMPANELMENT  
AND DISCIPLINARY COMMITTEE MEETING HELD ON 12.02.2019**

In continuation of Twenty Eighth Empanelment and Disciplinary Committee meeting held on 29.1.2019, the Twenty Ninth EDC meeting was held on 12.02.2019 at TNHSP under the Chairmanship of Project Director, Ms.P.Umamaheswari, I.A.S. The following members participated in the meeting:

The instructions given in the relevant G.O.s and the points discussed in the previous EDC meetings were followed.

The hospitals are now selected / graded based on the documents uploaded and updated by them online. The score sheet of the hospitals will be uploaded in the website for transparency in an un-editable form.

The list of Private Hospitals to be empanelled are enclosed in Annexure (A). The list of Private Diagnostic center to be empanelled are enclosed in Annexure (B).

Based on the documents submitted/inspection report hospitals who meet the criteria of the scheme empanelment have been selected. The hospital empanelled should get entry level NABH/ NQAS (GOI standards for Government hospitals) accreditation within twelve months. Otherwise they may not be able to continue in the scheme beyond that period. UIIC to communicate this to the hospital.

UIIC / TPA's are instructed to empanel the above list of hospitals, upload the packages, to appoint LO's and give training, create DMO, LO's login ID to access the scheme portal, supply of IEC material and other related activities. It is requested to sign the Memorandum of Understanding with the hospitals within ten days and submit a copy to TNHSP.

There are 65 Hospitals which were de-empanelled in Fifth EDC because of low performance and not applying online. Another list of 47 hospitals which was debarred from scheme because of Low performance on 2.11.17 is ratified in Fifteenth EDC. Out of the total 112(65 +47) hospitals de-empanelled, two hospitals requested for re-empanelment and those two hospitals are re-empanelled in this EDC meeting based on the assurance given by the hospitals that they will improve the performance and UIIC remarks. The list is enclosed (Annexure -C)
