Digital Health Incentive Scheme

For Ayushman Bharat Digital Mission (ABDM) Adoption



To give a boost to digital health transactions in the country, National Health Authority (NHA) has launched the Digital Health Incentive Scheme (DHIS).

Benefits of Digital Health Incentive Scheme



Incentivization for Digitization

Participating healthcare facilities, digital solutions companies (DSCs), and health tech companies can get reimbursed for the expenses incurred for digitization.



Efficiency in Healthcare Delivery

Seamless access to patients' longitudinal health records, simplification of healthcare processes such as registration, appointment, consultation, IPD admission, discharge, etc.



Improvement in Quality of Care

Improvement in quality of healthcare delivery due to evidence-based, accessible, and good-quality digitized health records.

Who all are eligible?

Health Facilities (such as hospitals and clinics) registered on Health Facility Registry (HFR) irrespective of the number of beds.

Laboratories, Diagnostic Centres, Imaging Centres, etc. registered on Health Facility Registry (HFR)

Health Facilities or Digital Solution Companies providing health locker services/teleconsultation, up to one transaction per day and five transactions, per month, per ABHA address will be eligible for DHIS.

Digital Solution Companies for transactions done by Health Facilities using their digital solutions such as HMIS and LMIS.

Please note: that virtual facilities providing teleconsultation created in the HFR will not be eligible.

'Transaction' means:

- Creation of an ABHA/ABHA address-linked health record by a healthcare facility or a health locker, including, teleconsultations, lab reports, etc.
- Token generation at a Health Facility using the ABDM Scan and Share feature

How is DHIS calculated?

Incentives are available after healthcare facilities and DSCs have achieved a minimum number of ABDM transactions each month, as explained below.

Sr. No.	No. of Transactions per Month	Incentives for Health Facilities	Incentives for DSCs
1	For creation of ABHA/ ABHA address linked health record: 101 and above transactions per month	Rs. 20 per transaction above 100 transactions per month	Rs. 5 per transaction above 100 transactions per month
2	For health lockers and teleconsultation transactions: 501 and above transactions per month	No incentive	Rs. 5 per transaction above 500 transactions per month

How to claim DHIS?

For a Health Facility

Step 1: Get registered on Health Facility Registry (HFR)* Step 2: Start using ABDM-enabled software Step 3: Log in HFR profile to register for DHIS Step 4: Log in HFR profile to claim incentives

For Digital Solution Company

Step 1: Get registered on ABDM Sandbox** Step 2: Integrate and go live with health facilities Step 3: Log in ABDM Sandbox Profile to register for DHIS

Step 4: Log in ABDM Sandbox Profile to claim incentive
