ORDER:

The Project Director, Tamil Nadu Health System Reform Program In her letter read above, has stated that in the pandemic of COVID-19 period, the Government of Tamil Nadu have decided to cover the testing of RTPCR samples referred by the Government officials to private empanelled labs under Chief Minister's Comprehensive Health Insurance Scheme as Government capacity to do RTPCR testing was limited in April 2020. Subsequently, in the core committee meeting held on 11.09.2020, it was recommended that expenditure towards 65% of the total RTPCR tests done will be borne by UIIC under existing policy and 35% of funds will be allotted from the State Budget to facilitate RTPCR testing through private empanelled labs. Orders were issued in the Government Order first read above, regarding the sanctioned an amount of Rs.101,84,05,570/- towards the settlement of RTPCR testing charges to Non- Chief Minister's Comprehensive Health Insurance Scheme beneficiaries which has been drawn and kept in the PD account of Tamil Nadu Health Systems Project.

2. Based on the request from UIIC in its E-mail dated 29.03.2022, the Project Director, Tamil Nadu Health Systems Project had been released an amount of Rs.50,00,00,000/- to UIIC from the amount sanctioned by Government towards adhoc payment for RT-PCR testing, pending finalization of the count of samples for Phase 1 and Phase 2 and taking into account the RT-PCR testing claims settled by UIIC was more than 200 Crore.

3. The Project Director, Tamil Nadu Health Systems Project has stated that 3 Verification Committees have been constituted in order to verify the authentication of RT-PCR Data (RT-PCR sample counts and Cost) furnished by the TPAs-MD-India, Vidal and Medi-Assist respectively with Tamil Nadu Health Systems Project officials and representatives from TPAs concerned. RT-PCR Phase 1 refers to the period from 29.04.2020 to 10.01.2021 Policy Year (IXH) and RT-PCR Phase 2 specifies the period from 11.01.2021 to 31.10.2021 Policy Period (XH). She has furnished the RT-PCR data furnished by the 3 TPAs to the Verification Committees with respect to phase-1 and phase-2 periods are summarized below respectively as follows:-

- 4. In addition to settled claims, the TPA-MD India furnished the data of 1,78,776 RT-PCR Samples for which payment has not been released by UIIC to the concerned labs. As the claims are unsettled, the assigned committee had challenges in verifying the amount settled against the UTR. Therefore, it was directed to verify RT-PCR Samples on the following basis with respect to unsettled claims:-
 - (i) Availability of SRF ID for all 1,78,776 unpaid samples
 - (ii) Comparison with counts given in the Deputy Director of Health Services.

5. Meanwhile, in the 21st Core Committee Meeting held on 09.06.2022, the Agenda pertaining to RT-PCR testing details for reconciliation and payment under Chief Minister's Comprehensive Health Insurance Scheme for Non- Chief Minister's Comprehensive Health Insurance Scheme beneficiaries was placed and the details as follows:

- 6. The Project Director, Tamil Nadu Health Systems Project has further stated that the following decision points were taken and incorporated in the 21st Core Committee meeting minutes. For the sample count of 15,60,598, Phase I amount becomes Rs.218,13,82,700/-. Out of the State share (35%) is Rs.76,34,83,945/-, Rs.50.00 Crores is already paid to UIIC. The balance amount of Rs.26,34,83,945/- has been settled to UIIC vide Proc.No.1887/TNHSP/Ins/2020, dt.16.06.2022. Phase II verification to be completed by the committee assigned and the payment will be done after the report.
- 7. UIIC in its letter dated 05.09.2022 has stated that among the 1,78,776 RTPCR Samples due for payment, 38 samples does not have valid SRF-IDs and hence can be deduced. Therefore, the Revised RT-PCR Sample Counts and Cost Estimate for phase 2 is as follows:

- 10. The Project Director, Tamil Nadu Health Systems Project has stated that the proposal for Closure of accounts for the Policy Year 2021 inclusive of RT-PCR claims for the year 2021 has been circulated in the Core Committee meeting held on 19.09.2022 and hence requested the Government to issue on the followings:
 - i. To permit the Project Director, Tamil Nadu Health Systems Project to release the State share of Rs.74,03,40,318/- for RT PCR Phase-2 by utilizing the remaining amount of Rs.25,49,21,625/- sanctioned by Government towards RTPCR payment as per G.O. (Ms) No. 184,H&FW (EAP1-1) Department, dated 25.03.2021 and by meeting the balance State share amount of Rs.48,54,18,693/- from the amount available with Tamil Nadu Health Systems Project which is Rs.542,07,90,806/-
 - ii. To permit the Project Director, Tamil Nadu Health Systems Project to adjust the amount of Rs.276,82,20,890/- to be refunded to UIIC on account of XH (2021) Closure with the balance amount refunded by UIIC and from the PMJAY amount received from NHA.

- iii. The remaining amount of Rs. 216,71,51,223/- which will be available in Tamil Nadu Health Systems Project will be remitted to the State treasury.
- 11. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders:
 - i. The Project Director, Tamil Nadu Health Systems Project is permitted to release the State share of Rs.74,03,40,318/- for RT PCR Phase-2 by utilizing the remaining amount of Rs.25,49,21,625/- sanctioned by Government towards RTPCR payment as per G.O. (Ms) No.184, Health and Family Welfare (EAP1-1) Department, dated 25.03.2021 and by meeting the balance State share amount of Rs.48,54,18,693/- from the amount available with TNHSP which is Rs.542,07,90,806/-
 - ii. The Project Director, Tamil Nadu Health Systems Project is permitted to adjust the amount of Rs.276,82,20,890/- to be refunded to UIIC on account of XH (2021) Closure with the balance amount refunded by UIIC and from the PMJAY amount received from NHA.
 - iii. The remaining amount of Rs. 216,71,51,223/- which will be available in TNHSP will be remitted to the State treasury.
