#### ORDER :

In the Government order first read above, the Chief Minister's Insurance Scheme for life saving treatment has been launched to ensure that poor and low income groups who cannot afford costly treatment, are able to get free treatment in Government as well as private hospitals for serious ailments. Under the scheme, each beneficiary family is insured for availing free treatment up to Rs.1.00 lakh.

2. In the Government order second read above, 1016 procedures have been included, including the following under the category of specialized procedures at a cost of Rs.1.5 lakhs:-

- Liver transplantation.
- Renal transplantation including post-transplant procedure for immunosuppressant therapy.
- Bone Marrow transplantation
- Cochlear Implantation and
- Stem cell transplantation

These surgeries cost more than Rs.1.5 lakhs ranging from Rs.3.00 Lakhs to Rs.10.00 lakhs, Since it was not possible to do procedures on cashless basis within Rs.1.5 lakhs. Hence, a Corpus fund of 10.00 crores was created so as to help the

needy and poor people especially children who undergo any one of the above specialized surgeries.

3. In the Government order third read above, among others, the Government have additionally sanctioned a sum of Rs.25.00 crore for the Corpus Fund under CMCHIS as one time measure and the corpus fund is also reimbursed through the deduction of 27% of the claims for procedures performed in Government hospitals.

4. During the Budget Speech for the year 2024-2025, the Hon'ble Minister for Finance and Human Resources Management has made the following announcement:-

**"With more than 50 per cent of treatment under health insurance scheme being availed in the Government hospitals, Tamil Nadu has become the leading State for nation. In order to further enhance healthcare services in Government hospitals, an amount of Rs.200 crore from the insurance corpus fund will be allocated towards upgrading their infrastructure facilities".**

5. In the letter fourth read above, The Project Director, Tamil Nadu Health Systems Project has stated that as per "Guidelines for the Chief Ministers Comprehensive Health Insurance Scheme 2022-2027" Clause 3 (ii) "All private hospitals performing high end procedures will pay 3% of the total high end package cost to corpus fund of TNHSP".

6. Based on the announcement, the Project Director, Tamil Nadu Health Systems Project has requested to sanction a sum of Rs.200.00 crores from the corpus fund of CMCHIS as a onetime measure towards upgrading infrastructure facilities of Government Hospitals by following the guidelines for the usage of the funds as per the Annexure I and Annexure II.

7. The Core Committee has approved the above proposal.

8. The Government, after careful examination, have decided to accept the request of the Project Director, Tamil Nadu Health Systems Project and accordingly sanction a sum of Rs.200.00 crores from the corpus fund of CMCHIS as a onetime measure towards upgrading infrastructure facilities of Government Hospitals by following the guidelines for the usage of the funds as per the Annexure I and Annexure II.

**GUIDELINES FOR SANCTIONING EXPENDITURE UNDER THE FUND**

S.No	Subject	Guidelines
i.	Objective of the Fund	Rs.200 crore from the Chief Minister's Comprehensive Health insurance Scheme Corpus Fund will be allocated towards upgrading the Government hospitals infrastructure facilities as a one time measure and it may be utilized to system modernization.
ii.	Sanctioning Authority	A Committee comprising of i. Additional Chief Secretary, Health and Family Welfare Department as Chairman ii. Mission Director, National Health Mission iii. Project Director, Tamil Nadu Health Systems Project - Member Convenor iv. Managing Director, TNMSC V. Joint Secretary, Finance Department vi. Director of Medical Education & Research vii. Director of Medical and Rural Health Service viii. Director of Public Health and Preventive Medicine IX. Any other members nominated by ACS, Health & Family welfare Shall sanction the funds required based on the requirements from the institutions, subject to availability of fund.
iii.	Details of work admissible under the Fund	Strengthening of infrastructure including supply of equipment as per the request from the institutions and as permitted in the proposed G.O.
iv.	Proposals for scheme	(i) For districts other than Chennai, a district level committee is to be formed under the chairmanship of the District Collector comprising of the Deans of the concerned Medical college Hospitals, concerned JDHS (Member Convenor) and DDHS, Executive Engineer, PWD. (ii) The committee should function as a standardised channel for scrutiny of the proposals received from the institutions for prioritising the requirements. (iii) The Committee shall also analyse if other available funds may be dovetailed for certain works. After thorough scrutiny, the proposals shall be forwarded through the District Collector to the Project Director, TNHSP for submission to the State Level Committee for

		<p>approval and sanctioning as per the order of priority.</p> <p>(iv) For Chennai district, the proposals are submitted by the Head of the Institutions through the concerned Directorates to the Project Director, TNHSP for submission to the State Level Committee for approval and sanctioning as per the order of priority.</p> <p>(v) While sending proposals for Corpus Fund, it should be certified along with the bank passbook that the total untied balance available under Institutional development/ hospital upgradation fund under the CMCHIS for the Institution is less than 10% of the average annual Institutional development/ hospital upgradation fund amount earned by the institution in the last two insurance years.</p>
v.	Executing Agency	<p>(i) For districts other than Chennai, the sanctioned work shall be executed through the PWD/TNMSC by the Deans/ JDHS/DDHS concerned, based on the decision of the committee headed by the District Collector. The District Collector shall be entrusted with the formal authority to monitor the execution of the work and its progress. The payment of the bills for the works may be done by the concerned institution after obtaining approval from the District Collector.</p> <p>(ii) For Chennai District, Head of Institutions in consultation with the head of Directorates may get the works executed through PWD/TNMSC. The payment of the bills for works will be done by the concerned Head of the Institutions.</p> <p>(iii) In case it is related to modernization of existing system, the Project Director, TNHSP may get the works executed through PWD/TNMSC/other agencies as decided by TNHSP.</p>
Vi.	Award of works	The Tender procedures and Procurement guidelines applicable to Government Departments shall be followed while awarding works.

vii.	Drawal and Release of Funds	(i) For Chennai and other districts, TNHSP shall draw and release the funds to the institution concerned. (ii) For modernization works taken up by TNHSP, the fund may be released to the concerned executive agency by the TNHSP.
viii.	Modification in the guidelines	Additional Chief Secretary to Government, Health and Family Welfare Department shall be authorized to modify any of the above guidelines based on exigencies that may arise then and there.
