The hospitals are now selected/graded based on the documents uploaded and updated by them online. The score sheet of the hospitals will be uploaded in the website for transparency in an un-editable form.

The list of hospitals in this EDC is as follows:-

Based on the documents submitted/inspection report hospitals who meet the criteria of the scheme empanelment have been selected. The hospital empanelled should get entry level NABH/ NQAS (GOI standards for Government hospitals) accreditation within twelve months. Otherwise they may not be able to continue in the scheme beyond that period. UIIC to communicate this to the hospital.

UIIC / TPA's are instructed to empanel the above list of hospitals, upload the packages, to appoint LO's for Government and Private Hospitals only and give training, create DMO, LO's login ID to access the scheme portal, supply of IEC material and other related activities. It is requested to sign the Memorandum of Understanding with the hospitals within ten days and submit a copy to TNHSP. The rest of the hospitals will be considered once they apply for NABH.






